**ORDER**

This petition has been filed by the petitioners to relax the condition which was imposed in the order dated 15.04.2024 passed in CrI.M.P.No.922/2023.

Heard the Learned Counsel for the petitioners and the Learned Public Prosecutor.

The Learned counsel for the petitioners submitted that the petitioners had appeared report before the Respondent Police Station daily at 5.00 p.m., for the past 17 days. Hence, the condition already imposed on the petitioners may kindly be relaxed.

The Learned Public Prosecutor has also admitted that the petitioners had appeared before the Respondent Police Station daily at 5.00 p.m., for the past 17 days and he strongly opposed to relax the condition.

On considering the submissions made by the Learned Counsel for the petitioners and the Learned Counsel for the state, this Court is of the view that the conditional order passed in CrI.M.P.No.994/2024 dated 15.04.2024 is modified and the petitioners are directed to report before the SHO of Bodinayakanur Taluk Police Station once in a week i.e., on every Sunday at 5.00 p.m., for the period of 04 weeks from 19.05.2024. After completion of their condition the petitioners are directed to appear before the concerned Court on every hearing without fail.

In the result, the condition is modified and the petitioners are directed to report before the SHO of Bodinayakanur Taluk Police Station once in a week i.e., on every Sunday at 5.00 p.m., for the period of 04 weeks from 19.05.2024.
