**ORDER**

This petition has been filed by the petitioner to relax the condition which was imposed in the order dated 06.04.2024 passed in CrI.M.P.No.922/2023.

Heard the Learned Counsel for the petitioner and the Learned Public Prosecutor.

The Learned counsel for the petitioner submitted that the petitioner had appeared report before the Respondent Police Station daily at 10.00 a.m., and 5.00 p.m., for the past 28 days. Hence, the condition already imposed on the petitioner may kindly be relaxed.

The Learned Public Prosecutor has also admitted that the petitioner had appeared before the Respondent Police Station daily at 10.00 a.m., and 5.00 p.m., for the past 28 days and he strongly opposed to relax the condition.

On considering the submissions made by the Learned Counsel for the petitioner and the Learned Counsel for the state, this Court is of the view that the conditional order passed in CrI.M.P.No.922/2024 dated 06.04.2024 is modified and the petitioner is directed to report before the SHO of All Women Police Station, Bodinayakanur once in a week i.e., on every Sunday at 5.00 p.m., for the period of 04 weeks from 19.05.2024. After completion of her condition the petitioner is directed to appear before the concerned Court on every hearing without fail.

In the result, the condition is modified and the petitioners are directed to report before the SHO of All Women Police Station, Bodinayakanur once in a week i.e., on every Sunday at 5.00 p.m., for the period of 04 weeks from 19.05.2024.
