This petition is coming up on this day before me for hearing in the presence of Tr.C.Thangaprabhu, Learned Counsel for the petitioner and the Learned Public Prosecutor for the State and this Court passed the following:

#### **ORDER**

This petition has been filed by the petitioner/accused U/s.438 of Code of Criminal Procedure seeking anticipatory bail.

## 2. The Nitty-Gritty of the prosecution case is as follows:

On 10.05.2024 at 8.30 p.m., the petitioner and co accused assaulted the complainant and intimidated them with dire consequences. Therefore the case registered against the petitioner U/s.147, 148, 294(b), 323, 342, 324 and 506 (ii) of IPC.

- 3. Heard both sides.
- 4. The points for determination is that can anticipatory bail be granted to the petitioner?

#### Answer:

- 5. As disclosed from the FIR, the petitioner and co accused assaulated the complainant and intimidated them with dire consquences. The victim has already been discharged from the hospital. Having considered the nature of offences and circumstances of the case, I inclined to release the petitioner on anticipatory bail.
- 6. Therefore it is ordered that in the event of her arrest by the Respondent or on her surrender before the Learned Judicial Magistrate at Aundipatty, within 15 days from the date of this order, she shall be released on anticipatory bail on her executing a bond for sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties each for a like sum. Following conditions are imposed on the petitioner:-
- i) The petitioner shall appear before the SHO Myladumparai Police Station daily at 10.00 a.m., and 5.00 p.m., for the period of 30 days from the date of release on bail.
- ii) The petitioner shall not tamper with evidence or witnesses either during the investigation or trial.
- iii) The petitioner shall not abscond either during the investigation or trial.
- 7. On breach of any of the aforesaid conditions, the Learned Magistrate / Trial court is entitled to take appropriate action against the petitioner in accordance with law as laid down by the Hon'ble Supreme Court in P.K.Shaji Vs- State of Kerala (2005) AIR SCW 5560).

8. If the petitioner/accused thereafter abscond, a fresh FIR can be registered under Section 229-A IPC.
