This petition is coming up on this day before me for hearing in the presence of Thiru.K.Ajmalkhan, Learned Counsel for the petitioners and the Learned Public Prosecutor for the State and this Court passed the following:

**ORDER**

This petition has been filed by the petitioners/accused U/s.438 of Code of Criminal Procedure seeking anticipatory bail.

**2. The Nitty-Gritty of the prosecution case is as follows:**

On 21.05.2024 at about 2.30 P.M. the petitioners abused and assaulted the complainant. Further they robbed cell phone and intimidated the complainant with dire consequences. Therefore the case registered against the petitioners U/s. 147, 294(b), 427, 323, 506(i) , 379 of IPC and Section.4 of TNPHW Act.

3. Heard both sides.

4. The points for determination is that can the petitioners be released on anticipatory bail ?

**Answer :**

5. The petitioners and complainant are neighbours. The complainant is constructing a new house adjoining to the house of the petitioners due to which the incident ensued. Considering the fact that the incident ensued over civil dispute, I inclined to release the petitioners on anticipatory bail.

6. Therefore it is ordered that in the event of their arrest by the Respondent or on their surrender before the Learned Judicial Magistrate at Uthamapalayam, within 15 days from the date of this order, they shall be released on anticipatory bail on their each executing a bond for sum of Rs.10,000/- (Rupees Ten Thousand Only) with two sureties each for a like sum. Following conditions are imposed on the petitioners :-

i) The petitioners shall appear before the SHO Chinnamanur Police Station daily at 10.00 a.m., and 5.00 p.m., for the period of 15 days from the date of their release on bail.

ii) The petitioners shall not tamper with evidence or witnesses either during the investigation or trial.

iii) The petitioners shall not abscond either during the investigation or trial.

7. On breach of any of the aforesaid conditions, the Learned Magistrate / Trial court is entitled to take appropriate action against the petitioners in accordance with law as laid down by the Hon'ble Supreme Court in P.K.Shaji – Vs- State of Kerala ( 2005) AIR SCW 5560).

8. If the petitioners/accused thereafter abscond, a fresh FIR can be registered under Section 229-A IPC.
