This petition is coming up on this day before me for hearing in the presence of Thiru. K. Ajay Durgesh, Learned Counsel for the petitioners and the Learned Public Prosecutor for the State and this Court passed the following:

<u>ORDER</u>

The petitioners and co-accused were ordered to be released on Anticipatory bail with condition in the order made in Crl.M.P.No. 349/2024 dated 12.02.2024. Already the petitioners have not surrendered themselves and obtained bail from the Court as ordered above for two occasions. The present petition is filed seeking extension of time to surrender and furnish the sureties.

- 2. Heard both sides.
- 3. The points for determination is whether the time can be extended for surrender and furnishing the sureties by the petitioners?

In Crl.M.P.No.349/2024 the petitioners were ordered to be released on Anticipatory Bail with conditions on 12.02.2024 by this Court. Subsequently in two occasions, time is extended for surrender and furnishing sureties before Court. Particularly in the order made in Crl.M.P.No.1171/2024 dated 29.04.2024, this Court directed the petitioners to deposit a sum of Rs.500/- each into the District Legal Service Authority, Theni on or before 09.05.2024. The petitioners have neither deposited the said amount nor surrendered themselves before the Court and furnish the security as ordered.

Further the petitioners have not putforth any reason for not complying with the earlier order, Time cannot be extended indefinitely as required by the petitioners that too in Anticipatory bail. So I find no merits in the petition on hand. Therefore the petition is deserves to be dismissed, accordingly the point is answered.

In fine, this petition is dismissed
