

Note :	1)	The concerned Presiding Officers are directed to relieve the concerned employees who are under order of transfer with a direction to join their new postings <u>on the date of effect of this order.</u> Entry of transfer & posting be taken in Service Book of the concerned employee's.
	2)	The concerned employees who are promoted to the Higher Post should exercise the option for fixation of pay as per Government Resolution, Finance Department No. Pay/1082/CR/1100(1)-SER-3, dated 6 th November 1984, within one month from the date of their promotion, <i>if the A.C.P. benefit of promotional post is not sanctioned to them previously and if the option is beneficial to them.</i>
	3)	The concerned establishment to fix the pay of promoted employees as per Maharashtra Civil Service (Pay) Rules, 1981.
	4)	The above employees are directed to submit their requisite information for Biometric attendance to concerned establishment.
	5)	The employees who are transferred on their own request as shown by (*) are not entitled for T.A./D.A., Joining time and Joining Pay etc.
	6)	The appointment of Shri Chandpasha Nyayahmed Shaikh is purely temporary. If the Court is disbanded, his service shall be terminated, being Junior most Jr.Clerk, but as and when vacancy arises, he shall be re-appointed in Judicial District Latur.
	7)	The rules and regulations made by the Hon'ble High Court regarding Inter District transfer is binding on Shri Chandpasha Nyayahmed Shaikh and Shri Mahadev Gundappa Lakshete.
	8)	Shri Chandpasha Nyayahmed Shaikh and Shri Mahadev Gundappa Lakshete are transferred on their own request so they are not entitled for T.A./D.A., Joining time and joining time pay etc.
	9)	<u>The appointments of candidate No.27/2024 in select list of Jr.Clerk is subject to following conditions.</u>
	i)	The posting of above newly appointed Jr.Clerk is purely temporary on ad-hoc basis and his service is liable to be terminated without assigning any reason and without notice thereof and if he desire to resign the post he should give one month notice or deposit one month pay in lieu thereof. He will have to take on oath of allegiance of constitution of India at the time of joining appointment. Further he is informed that, if he fails to join the appointment <u>within seven days</u> from the date of effect of this order after the service of appointment letter, his appointment will automatically stands cancelled and his name will be struck off from the <u>Select list of Jr.Clerk for the year 2024.</u>
