
Instructions:

1. No person shall be eligible for appointment, if he/she has completed 34 years ((however age is relaxed for 5 years to the categories of BC/SC/ST & 10 years for Physical Handicapped persons) or not attained the age of 18 years on 01/07/2023.

2. Mere applying to posts does not confer the right of claim over the post or to call for skill test/ interview.
3. The Appointing Authority reserves right to cancel or modify any instructions issued in the notification.
4. The appointment shall be strictly on contract basis and on remuneration basis as mentioned across posts.
5. The selected candidate has to enter agreement with the appointing authority on the terms and conditions mentioned in the agreement.
6. **The application should be submitted in a sealed cover with super scribing the name of the post on the cover only through Regd Post or through courier.**
7. Applications will not be received by hand from the individuals.
8. Suppression of information or furnishing false information entail the rejection of candidature apart from criminal action.
9. The applicant should be with active health and sound mind.
10. Applications with incomplete information are liable to be rejected and no correspondence in this regard will be entertained.
