Applications are invited from eligible candidates for filling up of the posts of Court Assistant and Court Attendant in the Special Judicial Second Class Magistrate Courts in the Unit of Warangal, for a period of two years:

ELIGIBILITY CRITERIA FOR THE POST OF COURT ASSISTANT:

(i) Any retired person, who has not exceeded 64 years of age as on 20.02.2023 and who has held any post in the Telangana Judicial Ministerial and Subordinate Service or any retired person who held the post of Assistant, Examiner, Typist, Copyist and above in the T.S High Court Service is eligible for appointment as Court Assistant.

(ii) Provided that, if suitable retired employee from Telangana Judicial Ministerial and Subordinate Service and High Court Service is not available, an outsider can be appointed, if he/she possess the following qualifications:

- (a) Must have passed Graduation or any equivalent examination.
- (b) Who has completed the age of 18 years and must not have completed the age of 34 years as on 20.02.2023.

Preference will be given to the local candidates, i.e., persons who are living in the same station or near about place.

ELIGIBILITY CRITERIA FOR THE POST OF COURT ATTENDANT:

(i) Any retired person who held the post of Office Subordinate or any other post in the Last Grade Service in the Subordinate Courts or the High Court service.

(ii) Provided that, if suitable retired employee from the Last Grade Service in the Subordinate Courts and the High Court Service does not respond to the recruitment notification or otherwise not available, an outsider can be appointed, if he possesses the following qualifications :

- a) Must have passed 7th Class examination or an equivalent examination.
- b) Must have completed the age of 18 years and must not have completed the age of 34 years as on 20.02.2023.


Preference will be given to the local candidates, i.e., persons who are living in the same station or near about place.

GENERAL INSTRUCTIONS:

1. The duly filled in applications shall be submitted strictly in the prescribed proforma, along with all the necessary copies of documents, such as duly attested qualification certificates, retirement proceedings etc., to this Office on or before 15.02.2023 by 05.00 p.m. and applications received after due date and time will not be entertained.
2. As per the instructions of the Hon'ble High Court in ROC No. 802/SO/97, dated 29.01.1998, the Spl. Judicial Second Class Magistrate Courts are functioning for (05) days in a week, i.e., from Monday to Friday on working days between 7.30 a.m to 10.30 a.m.
3. The appointment to the above post is purely on temporary basis, on payment of monthly honorarium, i.e., Rs.5,000/- to the Court Assistant and Rs.3,000/- to the Court

Attendant for a period of two years and the outsiders appointed for the said post do not confer any right for future employment on regular basis.

4. No TA will be paid for candidates for journey performed in connection with recruitment.
5. The appointing authority reserves the right to cancel the notification without assigning any reason thereof.
6. Applications with insufficient information, without necessary enclosures and without proper attestation will be summarily rejected and no correspondence in this regard will be entertained.
7. This office will not be responsible for any delay caused by the postal or any other service, viz., courier service, etc.,
