The individuals shall report to duty within (7) days. The individuals shall execute a Contractual Engagement (Deed of Agreement) immediately after reporting to duty. The individuals shall produce a medical fitness certificate issued by the competent authority not below the rank of Civil Surgeon or District Medical Officer at the time of joining.

The services of the above individual are liable to be terminated at any time without any notice for unsatisfactory performance or on administrative grounds.

If the above individuals do not join duty in the said post within stipulated time, his/her appointment shall be deemed to be cancelled.
