
Subject:- Regarding Suits transferred from the Hon'ble High Court, Bombay, on enhancement of pecuniary jurisdiction of this Court upto Rs.10 Crore.

In pursuance of the directions of the Hon'ble Principal Judge Shri Anil Subramaniam, this is to inform that upon implementation of the Bombay City Civil Court (Amendment) Act, 2023 (Mah.XLVI of 2023), enhancing the jurisdiction of this Court upto Rs. 10 Crores, number of Suits have been transferred to this Court from the Hon'ble High Court, Bombay, which shall remain at the main branch in pursuance of the earlier policy decision taken as per notice dated 16.04.2014 issued by the Registrar (O.S.)/ Prothonotary and Senior Master, High Court, Bombay, irrespective of the fact that the matter pertain to jurisdiction within the limits of branch of this Court at Dindoshi, **clarifying that the suits, in which cause of action has arisen within the jurisdiction of the Division of this Court at Dindoshi, will be transferred to the Court at Dindoshi provided all contesting parties appearing before the Court agree for transfer.**
