



## NOTICE

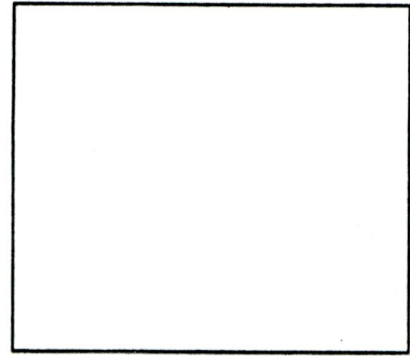
