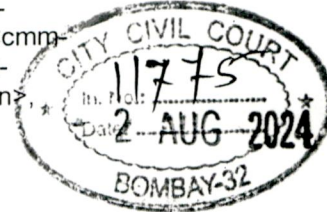

Sir / Madam,

Apropos the subject noted above, it is to inform you that, the Ld. Central Project Co-ordinator, High Court of Bombay, have informed that, the Hon'ble the Chief Justice have been pleased to approve the migration from e-filing 2.0 module to e-filing 3.0 and said notice is published on the official website of the High Court at Bombay and the Hon'ble e-Committee have specifically instructed that, e-filing of the District and Taluka Courts will not be accessible to all the stakeholders during the process of migration, and as

such, the actual technical activity of migration will take place on 7th, 8th and 9th August, 2024. Therefore, e-filing will not be available to all the District and Taluka Courts and ex-cadre Courts on aforesaid dates and has requested to convey to the District and Taluka and ex-cadre Courts in the State of Maharashtra about non-availability of e-filing facility.

Therefore, please take a kind note that, on 7th, 8th and 9th August, 2024, e-filing will not be available to all the Stakeholders of District and Taluka Courts and during said period, cases may be filed physically alongwith soft copies of the physically filed cases. Soft copies so tendered, may be uploaded in the document uploading module of the CIS.

Please take a note of the same and issue necessary directions to all the Stakeholders and report compliance to this office before 7th August, 2024.
