Urgent matters must be moved through the concerned officer only, between 11.00 a.m. to 01.15 p.m.
2. **Charge of Hon'ble Presiding Officer of Court taking Civil/Criminal matters who is on vacation/Leave during the vacation period, will be moved according to the Standing Order wide no. 180 of 2024 dated 05.08.2024 and Corrigendum to Office Order No.180 of 2024 dated 19.10.2024 during working days (Annexed herewith) and in the absence of the Presiding Officer as per Standing Order the Urgent application will be placed before the appropriate Hon'ble Judge as shown in enclosed chart.**
3. Hon'ble Presiding Officer of Court taking up Civil /Criminal matters who have not opt vacation during the aforesaid period the urgent applications of that Court will be entertained by the said Hon'ble Presiding Officer only.


