Order No. 331/G/2024

In view of the direction contained in Hon'ble Court's Letter No. 44510-546/ A.D. (Misc) and Letter No. 49195-231/ A.D. (Misc) dated 28.08.2015, fifty names of candidates were called for from the District Employment Officer, District Employment Exchange, Darbhanga after scrutinizing their eligibility for conducting interview of the shortlisted candidates by the District Appointment committee for selection of ten Attenders in the judgeship. In the light of aforesaid direction, a category-wise list of 50 candidates was received from District Employment Exchange, Darbhanga. Interview of candidates was conducted on 02.12.2024 by the District Appointment Committee, Darbhanga. After Interview, the candidates as mentioned in the list attached with this order have been selected for temporary engagement for the post of Attenders in the Judgeship by the District Appointment Committee.

In the light of direction of the Hon'ble Court, the engagement of the Attenders will be treated as purely temporary engagement and not contractual appointment to the post, not exceeding for a period of one year at a time. Such engagement shall be ceased, when appointments on regular basis are made.

Further, the engagement of Attenders shall be cancelled on the ground of concealment of fact regarding eligibility criteria/furnishing incorrect information or concealment of material information, indiscipline, dereliction in duty, absence from work for more than three days without prior permission, any direction received from the Hon'ble Court regarding cancellation of their engagement in due course of time etc. without assigning any reason.

The selected candidates are directed to join as Attender in the judgeship within Seven working days from the date of publication of Final Result. The selected candidates are required to submit following documents (in original) alongwith the self attested photo copies :

1. Aadhar Card
2. Residential Proof
3. Certificate regarding Age Proof
4. Certificates of Educational Qualification
5. Affidavit regarding 'No Criminal case pending against him/her and he/she has never been dismissed from any Government Service'.
6. Medical Fitness Certificate issued by the Civil Surgeon/C.M.O.

The candidates are also directed to submit Five recent Passport size photograph at the time of their joining.

No T.A. shall be paid to the Attenders at the time of their joining.

The I/C Head Clerk, Civil Court, Darbhanga is directed to verify the documents submitted by the candidates at the time of their joining as per direction contained in this order and after verification, their application for joining will be placed before the undersigned for approval.

Further, the I/C Head Clerk, Civil Court, Darbhanga is directed to send list of candidates attached with this order to the System Officer, Civil Court, Darbhanga for uploading the list alongwith this order on the official website of Civil Court, Darbhanga. He is also directed to send the list of selected candidates alongwith this order to the District Employment Officer, District Employment Exchange, Darbhanga for communication to the selected candidates and to publish the list of candidates alongwith this order on the Notice Board. The I/C Head Clerk is further directed to send the list of selected candidates to the D.M., Darbhanga to display the same on the Notice Board of Collectorate, Darbhanga.

Let a copy of this order along with selection list be displayed on the Notice Board of Civil Court, Darbhanga

Let the 'Engagement Letter' be issued to the selected candidates (list attached with this order) in the light of direction contained in this order. The I/C Head Clerk is further directed to inform the selected candidates telephonically, to join immediately.

Let a copy of this order alongwith list of candidates be sent to the Hon'ble High Court, Patna for information.
