This petition is coming for hearing before me on this day in the presence of Tmt.P.Nivedha, Advocate for the petitioner and of Public Prosecutor for the respondent and this Court made the following

ORDER

Heard both sides.

This petition is filed U/s.438 of Cr.P.C, for seeking Anticipatory bail.

The Learned Counsel for the Petitioner/Accused has filed the Anticipatory Bail application and stated that the Petitioner/Accused has been charged by the Respondent Police U/Ss.294(b), 324, 506(ii) and 307 of IPC subsequently altered into 294(b), 324, 506(ii), 307, 326 and 212 of IPC for the alleged occurrence took place on 02.06.2024. FIR was registered on 02.06.2024.

The Learned Counsel for the Petitioner/Accused has contended that there is civil dispute between the parties. So a false case has been foisted against him. He is no way connected with the offence. Hence, prays to allow the petition.

Earlier petition was dismissed by this Court in Crl.M.P.No.3879/2024 on 19.06.2024.

The Learned Public Prosecutor has contended that totally 5 accused involved in this case. A1 detained under Goondas. A2 and A3 are father and mother of A1. The victim's hand totally cut by the accused. He caught hold the victim. The investigation has not yet been completed. Earlier petition dismissed on 19.06.2024 by this Court. Hence, he has serious objection to release the Petitioner/Accused on bail. However, admitted that the injured was discharged from the hospital.

Rival submissions of both sides considered. Upon considering the strong objection, facts and circumstances of the case and other facts, version of FIR, the Petitioner/Accused caught hold the victim and the investigation has not yet been completed, this Court is not inclined to grant Anticipatory bail to the Petitioner/Accused, hence the petition is dismissed.
