

District Judge (Entry Level) Examination 2023 Direct Recruitment from Advocates (Bar)

Applications from Indian Citizens are invited in the cadre of Chhattisgarh Higher Judicial Service in the revised pay scale of Rs. 144840-194660 under Level J-5 of new pay matrix in the cadre of Higher Judicial Service by direct recruitment from Advocates (Bar). Recruitment to these posts and conditions of service shall be governed by the Chhattisgarh Higher Judicial Service (Recruitment and Conditions of Service), Rules 2006, as on the last date of submission of application forms.

1- Application in prescribed format must reach the Registry by 31/08/2024 till 5.00 PM.

2- Date of Written Examination 10/11/2024 (Sunday).

Total Vacancy:- 37 (Unreserved – 30 {including 09 posts for women candidates}, Scheduled Castes -02, Scheduled Tribes - 02, Other Backward Classes- 03)

Eligibility:- 1) LL.B.
2) Has for atleast seven years been an advocate as on 01/01/2024.

Age :- He / She has attained the age of 35 years and has not attained the age of 45 years on the first day of January, 2024.

Examination Fee:- Rs. 700/- for Scheduled Castes, Scheduled Tribes and Other Backward Classes (non creamy layer) who are the bonafide residents of State of Chhattisgarh, and Rs. 1000/- for the candidates belonging to Unreserved Category and also for all the candidates belonging to Other States. Fee is to be deposited in the form of Challan only with SBI branches through Core Banking Network all over India. The original copy of Challan must be attached along with application form.
