- 5. Self-attested copy of ITR for last 3 years (if available),
- 6. Photocopy of Judgments in 5 Sessions Cases, represented as Defense Lawyer, (for the post of Dy.Chief Legal Aid Defense Counsel),
- 7. Photocopy of at least 5 cross examinations in Sessions Cases (for the post of Dy.Chief Legal Aid Defense Counsel).

GENERAL INSTRUCTIONS TO CANDIDATES :

 Separate Written Examination (Descriptive) will be conducted for the post of 1) Deputy Chief Legal Aid Defense Counsel and 2) Assistant Legal Aid Defense Counsel. Therefore candidates who have applied for both the posts are informed to appear for the written examination (descriptive) as scheduled above, without fail.

- 2. The Written Examination will be of Descriptive Type in the following areas viz., Indian Penal Code (IPC), Criminal Procedure Code (Cr.PC), Indian Evidence Act, The Constitution of India, Criminal Minor Acts & other Special Acts.
- 3. All Candidates should produce their Bar Council Enrollment Identity Card (for verification) before entering the examination Hall. Candidates will not be allowed to appear for the examination without submitting their identity card.
- 4. Candidates are advised to bring black and blue pen and pencil and eraser. Except the permitted writing material, applicants are not allowed to bring mobile phones, electronic or any other type of calculators, smart watches and rings with inbuilt memory notes, recording devices or any other electronic gadgets into the examination hall / room.
- 5. No applicant shall copy from the papers of any other applicant or permit his / her papers to be copied or give or attempt to give or obtain or attempt to obtain irregular assistance of any description.
- 6. No applicant shall misbehave in any manner or create a disorderly scene in the examination hall or harass the staff deployed for the conduct of the examination. Any such misconduct may lead to disqualification.
- Candidates appearing for the Written Examination are required to be present at the aforesaid venue an hour before the commencement of the written examination.

Written Examination will be followed by Final Interview by the Hon'ble Interview Committee on the same day.
