QUALIFICATIONS :-

i) A person, who has held any post in Telangana Higher Judicial Service or State Judicial Service and retired or resigned,

OR

ii) A person, who has held a post in the Telangana Judicial Ministerial Service not below the rank of Superintendent District Courts or Senior Civil Judge or Junior Civil Judge's Court and has a Law Degree.

OR

iii) A person, who has held a post of Section Officer and above in the Telangana Court Service and has a Law Degree,

OR

iv) A Non-practising Advocate with a practice at the Bar of not less than five years and who is above 45 years of age should file a certificate of voluntary suspension of practice issued by the Bar Council of state of Telangana.

OR

vi) Any retired Gazetted Officer possessing Law Degree or who has passed the Criminal Judicial Test (Full test consisting of the Indian Penal Countries of Criminal Procedures Indian Penal Code and the Code of Criminal Procedure) and who has are Andhra Pradesh Public Service Commission and who has exercised Magisterial powers during his tenure of service for not less than three years;

Who has atleast one year to complete 65 years of age at the date fixed by the year of recruitment shall alone be eligible.

DISQUALIFICATIONS:

A person

1) Who is a paracticing Advocate OR

2) Who is a Member of any State or Local Authority OR

- 3) Who is a Member of the State Legislature or of the Parliament OR 4) A person who is having held an Officer under the State or the Union Government or any Local Authority, has been dismissed or removed or compusorily retired from service or subjected to any other major penalty for misconduct, OR
- 5) A person who has been convicted and sentenced by a Court for an offence involving moral delinquency or is charged of any offence constituing moral trupitude proceedings are pending OR
- 6) A person unsound mind or who is deaf or mute or blind or suffering from Leprosy or any other contagious disease OR
- 7) A person adjudicated as insolvenent or an undercharged insolvent, OR
- 8) A contractor or a businessman or one intersted in a subsisting contract or any work being done for Central or State Government or a Local Authority within whose limits the Special Magistrate has to discharge his duties, shall not be eligible.

REVOCATION OF POWERS OF SPECIAL MAGISTRATES:

1) On appointment and while in service a Special Judicial Magistrate of Second Class or Special Magistrate of any other category may be removed without being called upon to show cause if he fails to attend three consecutive sittings of the Court without a written permission of the Chief Judicial Magistrate, Nalgonda as the case may be.

2) Powers conferred by the Court on Special Judicial Magistrate of Second Class shall automatically stand withdrawn on his/her attaining the age of 65 years.
