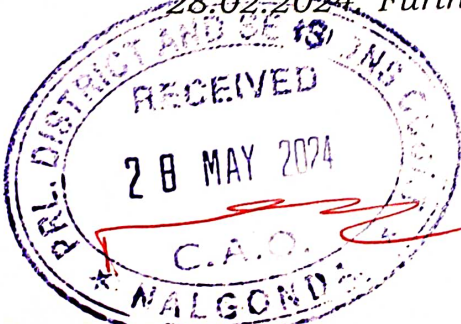

Sub:- Telangana State Judicial Services – Revision of Pay Scales of State Judicial Service Officers – Orders of the Hon'ble Supreme Court of India dated 04-01-2024 in W.P. (Civil) No.643 of 2015 for implementation of the various allowances – Resolutions of the CSDJ – Certain information called for - Reg.

Ref:G.O.Ms.No.04, General Admn. (J&RA) Dept.,dt.28-02-2024.

Pursuant to the orders of the Hon'ble Supreme Court of India in W.P. (Civil) No.643/2015 dt.04-01-2024, for implementation of the various allowances, the Government of Telangana, in due compliance has issued G.O.Ms.No.04, General Admn. (J&RA) Dept., dt.28-02-2024, defining the allowances payable/reimbursable to the Judicial Officers, w.e.f. 01-01-2016.

The "Committee for Service Conditions of the District Judiciary" constituted by the Hon'ble Apex Court, to oversee the proper implementation of the recommendations of the SNJPC, in respect of clearance of all the bills of working and retired Judicial Officers, has resolved as under:

"The Committee further directed "the PAO and DTO authorities to clear off all the bills which will be submitted in due course in compliance to G.O.Ms.04, GENERAL ADMINISTRATION (J&RA) DEPARTMENT dated 28-02-2024. Further the Registry is directed to address a letter to all



the unit heads to contact all the Retired Judicial Officers residing within their units to submit the arrears bills claiming the allowances granted vide the above G.O. The Registry shall also address a letter to all the unit heads to call for the particulars of the amounts drawn by the individual Judicial Officers category wise towards the above said allowances pursuant to the above said G.O. and submit the same to the High Court at the earliest for filing compliance report before the Hon'ble Supreme Court."

"The Committee resolved to direct the Registrar (Administration) to call for token numbers of bills from the unit heads and forward the same to the PAO/DTO authorities".

Therefore, all the Principal District & Sessions Judges / Unit Heads in the State are requested to process the bills of Retired Judicial Officers residing in the territorial area falling under your unit. You are further requested to submit the information regarding the particulars of the amounts drawn by the individual Judicial Officers category wise towards the above said allowances pursuant to the above said G.O. and token numbers of the pending bills from the unit heads to forward the same to the PAO/DTO authorities to the High Court on or before 27.05.2024.
