8. Candidates resorting to bring influence of any kind will be disqualified summarily.

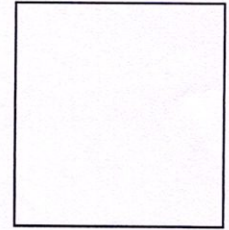
