Sub Prl. District & Sessions Judge, Mulugu - Fast Track Special Court – Filling up of vacancies in Fast Track Special Court for Expeditious Trial and Disposal of Rape & Protection of Children against Sexual Offences (POCSO) Act at Mulugu, appointment of **Junior Assistants (2 posts)** on contract basis – Orders – Issued – Regarding.

In pursuance to the notification issued vide reference 4th cited, oral interview has been conducted to the eligible candidate vide reference 6th cited, accordingly, the following orders are issued.

ORDER:

(1) Sri Palthiya Mahesh, S/o. Damodar, R/o. H.No. 5-106/34, Subhash Chandrabose Colony, Kamalapur, Mangapeta, Mulugu District,

(2) Sri Guguloth Ganesh, S/o.Sammaiah, R/o. Laxmidevipet Village, Venkatapur Mandal, Mulugu District,

are provisionally selected and appointed as **Junior Assistant** on contract basis and posted in the Court of Fast Track Special Court for expeditious trial and disposal of Rape and POCSO Act cases, Mulugu in the existing vacancy.

2. The above individuals are entitled to draw consolidated pay of **Rs.19,500/- per month** in terms of the G.O. reference 2nd cited.
3. The appointment of the individuals is purely on contract basis and will be for a period of one year or till functioning of Fast Tract Court or if at a later stage their services found not satisfactory, whichever is earlier.
4. They shall work in the court in which they are appointed and shall render unblemished service. They shall follow the norms of discipline, which the employees of a regular court follow including maintenance of Court timings.
5. The remuneration shown above shall be consolidated and not entitled any other monetary benefit.
6. The place of posting shall not be considered as a permanent arrangement during the contract period and they shall be liable to be deputed to such other place, as may be directed by the appointing authority.

7. The above individuals are entitled for only Casual leave per calendar year as per rules and they are not entitled for any kind of other leaves.
8. The above individual shall join duty within a period of one week from the date of receipt of this order.
9. The above individuals are informed that their appointment will take effect from the date of their joining duty.
10. The individuals shall execute a "CONTRACT AGREEMENT" in the form prescribed by the Hon'ble High Court for the State of Telangana, Hyderabad on a Non-Judicial Stamp paper worth of Rs.200/- in favour of Principal District & Sessions Judge, Mulugu in terms of the conditions laid by the Hon'ble High Court in Roc.No. 1996/E1/2003, dated 21.04.2003 within 15 days from the date of their joining in the post.
11. The individuals shall produce a medical fitness certificate issued by the Medical Officer not below the Rank of Civil Surgeon at the time of joining duty before Special Judge of the Fast Track Court for Expeditious Disposal of Rape and POCSO Cases, Mulugu.
12. The above said individuals are informed that their appointment is made on contract basis and their services are liable to be terminated at any time without assigning any reason or without issuing any notice.
13. If the individuals fails to join the duty within 15 days from the date of this order, the appointment shall be deemed to be canceled.

This order shall come into force from the date of joining by the individual.
