I) ELIGIBILITY CRITERIA:-

a) Court Assistant :-

- 1) Must have passed Intermediate examination conducted by Telangana State Board of Intermediate Education or its equivalent.
- Any retired person who held any post i.e. Assistant, Examiner, Typist, Copyist and above in the Judicial Department is eligible.

b) Court Attendant :-

- 1) Must have passed 7^{th} class examination for the post of Court
- Any retired person who held the post of Attender, Process Server or in any post in the Last Grade Service in the Judicial Department is eligible.

II) AGE :-

- As on 01.07.2022 the candidates must not have completed (34) years and must have completed (18) years. The relaxation of maximum age limit is 5 years in respect of SC/ST and BC candidates and 10 years in respect of physically handicapped and Ex-Servicemen.
- Any retired employee who crossed the age limit of 65 years shall not be eligible for the appointment of Court Assistant and Court Attendant.
