In pursuance to the notification issued vide reference 4^{th} cited, oral interview has been conducted to the eligible candidate vide reference 6^{th} cited, accordingly, the following orders are issued.

ORDER:

Sri Amgoth Hemanth Kumar, S/o. Jaisingh, R/o.H.No.1-58, Madanapalle Village, Mulugu Mandal and District is provisionally selected and appointed as Stenographer Grade III on contract basis and posted in the Court of Fast Track Special Court for expeditious trial and disposal of Rape and POCSO Act cases, Mulugu in the existing vacancy.

- 2. The above individual is entitled to draw consolidated pay of Rs.19,500/- per month in terms of the G.O. reference 2^{nd} cited.
- 3. The appointment of the individual is purely on contract basis and will be for a period of one year or till functioning of Fast Tract Court or if at a later stage his services found not satisfactory, whichever is earlier.
- 4. He shall work in the court in which he is appointed and shall render unblemished service. He shall follow the norms of discipline, which the employees of a regular court follow including maintenance of Court timings.
- 5. The remuneration shown above shall be consolidated and not entitled any other monetary benefit.
- 6. The place of posting shall not be considered as a permanent arrangement during the contract period and he shall be liable to be deputed to such other place, as may be directed by the appointing authority.

- The above individual is entitled for only Casual leave per calendar year as per rules and he is not entitled for any kind of other leaves.
- The above individual shall join duty within a period of one week from the date of receipt of this order.
- 9. The above individual is informed that her appointment will take effect from the date of her joining duty.
- 10. The individual shall execute a "CONTRACT AGREEMENT" in the form prescribed by the Hon'ble High Court for the State of Telangana, Hyderabad on a Non-Judicial Stamp paper worth of Rs.200/- in favour of Principal District & Sessions Judge, Mulugu in terms of the conditions laid by the Hon'ble High Court in Roc.No. 1996/E1/2003, dated 21.04.2003 within 15 days from the date of his joining in the post.
- 11. The individual shall produce a medical fitness certificate issued by the Medical Officer not below the Rank of Civil Surgeon at the time of joining duty before Special Judge of the Fast Track Court for Expeditious Disposal of Rape and POCSO Cases, Mulugu.
- The above said individual is informed that his appointment is made on contract 12. basis and his services are liable to be terminated at any time without assigning any reason or without issuing any notice.
- If the individual fails to join the duty within 15 days from the date of this order, the appointment shall be deemed to be canceled.

This order shall come into force from the date of joining by the individual.
