ORDER :

The Prl. District Judge, Mulugu, is pleased to appoint the following candidate, approved by the Hon'ble High Court for the State of Telangana, vide reference 2nd cited, as **Copyist** (Category-12) of Telangana Judicial Ministerial and Subordinate Service Rules, 2018 under Direct Recruitment in the Unit of Principal District Judge, Mulugu, **pending verification of your antecedents by concerned police**, in the time scale of pay of **Rs. 22900-690-24970-720-27130-750-29380-830-31870-940-34690-1030-37780-1110-41110-190-44680-1280-48520-1400-52720-1500-57220-1630-62110-1730-67300-1850-69150** and posted in the following Courts as detailed below :

The individual is directed to report before her respective Presiding Officer and submit her physical fitness certificate issued by the competent authority not below the rank of Civil Surgeon or District Medical Officer along with her joining report and three sets of Attested copies of her certificates.

The appointment of the individual **is pending verification of her antecedents by the concerned police**, if any adverse remarks reported in the verification of antecedents, her provisional selection to the post shall be reviewed and if necessary the Hon'ble High Court may substitute the candidate with next meritorious candidate by following the rule of reservation or may carry forward the post to the next recruitment.

The appointment of the above Individual is purely on temporary basis and is liable to be terminated at any time without any notice and without assigning any reason therefor or on administrative grounds.

The above Individual is on probation for a total period of two years on duty within a continuous period of three years from the date of her joining in the post.

If the above Individual is employed in any post in the State/Central Government or in any organization or undertaking at present, she shall resign to that post and submit a copy of relieving order invariably.

In case, the individual is not employed in any pensionable post wither in the State/Central Government or in any organization or undertaking, their appointment will be governed by the Contributory Pension Scheme (CPS) in terms of G.O. Ms.No.655, Fin (PEN-I) Department, dated 22/09/2004. The officer concerned is directed to get the said entry noted in the Service Register and at all the places where ever necessary of the respective individual.

The above Individual has to deposit an amount of Rs. 10000/- towards security deposit as per Rule-22, Sub-rule b of TSJM Service Rules-2018 within a month from the date of her appointment. If fails to deposit the security required her probation shall be deemed to have been terminated and the appointing authority shall forthwith, by order, discharge her from the service.

If the appointee does not join her post within 60 days from the date of receipt of this order of appointment, it shall be deemed to have been cancelled without any further notice.

The newly recruited individual is required to stay at the Headquarters and whenever she leave the Headquarter, she shall obtain prior permission of her Officer.

The Superintendent/CMO of the concerned Court is instructed to impart practical training to the newly recruited staff posted to her respective Court.
