The Principal District and Sessions Judge, Jogulamba Gadwal is pleased to issue the following orders of appointment of Examiner (Cat-11).

1. T.Nandini D/o T.Vishnuvardhan Reddy, R/o H.No.2-118, Kothapally village, Gadwal, Jogulamba Gadwal District-509125 (T.S), who has been selected as Examiner (Cat-11 of T.J.M.S.S) against Roster Point No. 01 (OC-W) and approved by the High Court is appointed as Examiner (Cat-11) and posted as Examiner in the Prl. Senior Civil Judge's Court, Gadwal, in the existing vacancy. Further she is deputed to work in Prl. District and Sessions Court, Jogulamba Gadwal until further orders.

Note:-

1. These orders will come into force with immediate effect.
2. The individual is informed that, she is appointed purely on temporary basis and her services are liable to be terminated at any time without notice and assigning any reasons.
3. The individual is directed to report to duty on or before 10-01-2024 in posting court from the date of dispatch of these orders, failing which the appointment orders shall stands cancelled.
4. The individual is directed to submit Physical Fitness Certificate issued by a Medical Officer, not below the rank of a Civil Surgeon or a District Medical Officer and the Identity Proof while joining duty in the said appointed post.
5. The individual is appointed to the post of Examiner shall, for the due and faithful performance of duties attached thereto, deposit an amount of Rs.10,000/- (Rupees Ten Thousand only) towards security at the time of joining report.
6. The individual shall abide by the Conduct and other Service Rules.
7. The individual is informed that, they will be governed by the contributory pension scheme as per G.O.Ms.Nos.653, 654 & 655, Finance (Pension-I) Dept.,dt. 22.09.2004 and the pension scheme under A.P. Revised Pension Rules, 1980 not applicable to them.
8. The seniority of candidate is fixed as per their merit in view of decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others (2003) 5 SCC 604.
9. The individual will be on probation for a total period of two years on duty within a continuous period of three years as per Rule 13(a) of TJMSS Rules 2018.
