
**ORDER:** Dis.No. 10/24 Dt. 03.01.2024.

The Principal District and Sessions Judge, Jogulamba Gadwal is pleased to issue the following orders of appointment of Stenographer Grade-III (Cat-6).

1. Ms.Mangali Vaishnavi D/o Mangali Narsimhulu, R/o H.No.8-1-749, RTC colony, Nalgonda, Nalgonda District- 508001 (T.S), who has been selected as Stenographer Grade-III (Cat-6 of T.J.M.S.S) against Roster Point No. 01 (OC-W) and approved by the High Court is appointed as Stenographer Grade-III (Cat-6) pending verification of her antecedents by the concerned police and is posted as Stenographer Grade-III in the Prl.Junior Civil Judge's Court Gadwal, in the existing vacancy. Further she is deputed to work in Prl.District and Sessions Court, Jogulamba Gadwal until further orders.

Note:-

1. These orders will come into force with immediate effect.
2. The individual is informed that, she is appointed purely on temporary basis and her services is liable to be terminated at any time without notice and assigning any reasons.
3. The individual is directed to report to duty on or before 10-01-2024 before their posting court from the date of dispatch of these orders, failing which the appointment orders shall stands cancelled.
4. The individual is directed to submit Physical Fitness Certificate issued by a Medical Officer, not below the rank of a Civil Surgeon or a District Medical Officer and the Identity Proof while joining duty in the said appointed post.
5. The individual is appointed to the post of Stenographer Grade-III shall, for the due and faithful performance of duties attached thereto, deposit an amount of Rs.10,000/- (Rupees ten thousand only) towards security at the time of joining report.
6. The individuals shall abide by the Conduct and other Service Rules.
7. The individual is informed that, she will be governed by the contributory pension scheme as per G.O.Ms.Nos.653, 654 & 655, Finance (Pension-I) Dept.,dt. 22.09.2004 and the pension scheme under A.P. Revised Pension Rules, 1980 not applicable to them.
8. The seniority of candidates is fixed as per their merit in view of decision of the Hon'ble Supreme Court in Bimlesh Tanwar Vs State of Haryana and others (2003) 5 SCC 604.
9. The individual is further informed that, her appointments is made pending verification of her antecedents by the concerned police. As such in antecedents reports to be received from the Police concerned in due course, if any adverse remarks are reported against the candidates as to her antecedents and character, her appointments will be terminated without any notice and without assigning any reasons.
10. The individuals will be on probation for a total period of two years on duty within a continuous period of three years as per Rule 13(a) of TJMSS Rules 2018.
