1. The above individual is directed to report to duty before the Presiding Officer concerned on or before 08-04-2024 from the date of receipt of this order, failing which the appointment would be deemed to have been cancelled and no further correspondence will be entertained.
2. The period of contract of the above individual shall come into force from the date of joining in the post to till the actual need ceases.
3. The persons appointed in LADCS office, District Legal Services Authority, Jogulamba Gadwal on Contract Basis, shall be paid remuneration as fixed by the Hon'ble TSLSA, Hyderabad from time to time.
4. The above individuals are required to submit Physical Fitness Certificate, issued by the Medical Officer not below the rank of Civil Surgeon at the time of reporting duty and she is further directed to enter into a contract agreement in the proforma prescribed for submission to the Hon'ble TSLSA, Hyderabad.
5. The person appointed shall be purely on contract basis as per Rule-9 of Telangana State and Subordinate Service Rules, read with standing orders of the Hon'ble High Court issued from time to time and they shall not be regarded as a member of service and shall not be entitled for preferential right to any other appointment and liable to be terminated at any point of time without issuing any notice.
