Note: -

1. The above individual is directed to report to join duty before the presiding officer concerned on or before **15-07-2024**, failing which the appointment would be deemed to have been cancelled and no further correspondence will be entertained.
2. The period of contract of the above individual shall come into force from the date of joining in the post till the actual need ceases.
3. The person appointed Fast Track Sessions Court on Contract Basis, shall be paid remuneration as fixed by the Government from time to time.
4. The above individual is required to submit Physical Fitness Certificate, issued by the Medical officer not below the rank of Civil Surgeon at the time of reporting duty.
5. The above is further directed to enter into a contract agreement in the proforma prescribed for submission to the Hon'ble High Court.
5. The person appointed shall be **purely on contract basis (Temporary basis)** as per Rule-9 of Telangana State and Subordinate Service Rules, read with standing orders of the Hon'ble High Court issued from time to time and they shall not be regarded as member of service and shall not be entitled for preferential right to any other appointment and **liable to be terminated at any point of time without issuing any notice.**
6. If a candidate possesses qualifications that surpass the eligibility requirements for the post, his employment may be subject to termination at any time, even in cases where they have a criminal record.
