### I. ELIGIBILITY:

- a) The Candidates must have **passed Intermediate Examination** conducted by A.P./Telangana State Board of Intermediate Education or its equivalent examination for the post of **Court Assistant** and must have passed **7th class** examination for the post of **Court Attendant**.
- b) Any retired person who held any post i.e., Junior Assistant, Examiner, Typist, Copyist and above in the Judicial Department is eligible for appointment of Court Assistant. Any retired person who held the post of Attender, Process Server or in any post in the last grade service in the Judicial Department is eligible for appointment of Court Attendant.

## II. AGE:

- a) As on 01.08.2025 the candidates must not have completed (34) years and must have completed (18) years. The relaxation of maximum age limit is 5 years in respect of SC/ST and BC candidates and 10 years in respect of physically handicapped and Ex-Service Men.
- b) Any retired employee who crossed the age limit of 65 years shall not be eligible for the appointment of Court Assistant and Court Attendant.
