ORDER:-

As per the reference cited, the Department of Justice, Government of India, has allocated funds for the provision of additional LAN connections under the e-Courts Phase III Project. A total of 175 courts in Tamil Nadu and the Union Territory of Puducherry will be provided with additional LAN infrastructure, with each court receiving four (4) LAN points, amounting to a total of 700 points.

The Hon'ble High Court of Madras has procured Cisco Switches with 1 Gig SFP ports for each court through ELCOT, Chennai. The remaining installation work—including I/O jack installation, cabling, casing, and related activities—will be executed by private vendors through a triple quotation system, with a cost cap of Rs.4,000 per LAN point.

To ensure transparency and efficiency, it has been decided to invite quotations from private vendors through web publication.
