CIRCULAR

All the Principal Judges shall display, the names of the Judicial Officer, Superintendent, Stenographer, Clerk, one Technical staff and Peon or any other staff deputed for urgent Civil and Criminal work during holidays. / Summer Vacation and it shall be uploaded and displayed on the website as well as Notice Board with telephone number of concern Superintendent or other officials, so that litigants / Advocates may contact concerned in case of urgent civil case is to be filed with interim application for urgent relief as well as for urgent Criminal work.

The Judicial Officer at station and staff members shall not leave headquarter without prior permission of the Incharge of respective District.

The Principal District Judges and Heads of all departments under the administrative control of High Court Bombay shall apprise of the above circular and the concerned be put to notice that any deviation from this or avoidance of work or refusal of acceptance of filing on any ground whatsoever will be viewed seriously, if any such incident is noted.
