Applications are invited from eligible candidates for the post of “**Member**” (**2 Vacancies**), Permanent Lok Adalat, Pudukkottai. The Permanent Lok Adalat is consisting one Chairman and two members. The Chairman is a serving District Judge. The subject matters covered under the Public Utility Services Act shall be redressed by the Permanent Lok Adalat in consonance with the rules prevailing in force.

Selection Procedure:

The selection of “Member” (2 Vacancies) to the Permanent Lok Adalat, Pudukkottai will be based on merits, taking into account of the knowledge, Skills, Practical experience of the candidates. The selection shall be carried out by “Selection Committee” under the Chairmanship of the Chairman/Principal District Judge, District Legal Services Authority, Pudukkottai and it shall be approved by the Hon’ble Executive Chairman of Tamilnadu State Legal Services Authority, Chennai.

Eligibility & Qualification:

- The candidates must be a citizen of India and Local resident of Pudukkottai District.
- The candidates must have professional efficiency in the required field till the Super Annuation (or) Voluntarily Retired from Unblemished service.

- Age must have been above 55 years and below 62 years on the date of Notification.
- The candidate must be a sound mind person, who does not indulge in any kind of criminal activities.

Period of Service:

Five Years service or the maturity of 65 years of age.

Required Criteria :

1. The “Member” (2 Vacancies), Permanent Lok Adalat, Pudukkottai must possess Professional efficiency in the following fields;
 - Transport service for the carriage of passengers or goods by air, road or water; or
 - Postal, telegraph or telephone service; or
 - Supply of power, light or water to the public by any establishment; or
 - System of public conservancy or sanitation; or
 - Service in the hospital or dispensary; or
 - Insurance service; or
 - Education or educational institutions; or
 - Housing and real estate service;
 - Banking and financial services
2. The upper age limit for the service is 65 years, thereafter the service will be terminated.
3. The candidate must have soundness in physical and mental health.

Termination of services:

Services of any resource engaged in the office of Permanent Lok Adalat can be terminated at any time, without any prior notice in the following cases by the Chairman, District Legal Services Authority, Pudukkottai on recommendation of the Chairman, Permanent Lok Adalat, Pudukkottai or on the directions by Tamil Nadu State Legal Services Authority in writing.

1. He / she substantially breaches any duty or service required in the office.
2. Seeks or accepts any pecuniary gains from the litigant public or beneficiary is friend or relative of the Member.
3. Charged or Convicted for any offence by any court of law.
4. Indulges in any type of political activities.
5. Found incapable of rendering professional services of the required standards.

6. Failure to attend training programmes without any sufficient cause.
7. Indulges in activities prejudicial to the working of Permanent Lok Adalat, Pudukkottai office.
8. Using his / her position in Permanent Lok Adalat, Pudukkottai Office to secure unwarranted privileges or advantages for him/herself or others.
9. Acts in breach of code of ethics.
10. Remains absent without leave for more than two weeks.
11. If services are found unsatisfactory during the six-monthly performance review by the Tamil Nadu State Legal Services Authority, Chennai or District Legal Services Authority, Pudukkottai.
