**Subject:** Calling willingness of Advocates whose practice is more than 15 years for 40 hrs. Mediation Training Programme

Sir/Madam,

With reference to the subject noted above, I am to state that Main Mediation Centre, Bombay High Court is planning to arrange 40 hrs. Mediation Training Programme to those willing Advocates whose practice is more than 15 years. Therefore, it is necessary to send proposal to Government of Maharashtra for provision of funds. Hence, there is need to collect the information about number of willing Advocates for said training.

As per Rule 4 of Civil Procedure Mediation Rules Part II is as under:

*"The following shall be treated as qualified and eligible for being enlisted in the panel of mediators under Rule 3, namely:-*

- (a) (i) Retired Judges of the Supreme Court of India;
  - (ii) Retired Judges of the High Court;
  - (iii) Retired District and Sessions Judges or retired Judges of the City Civil Court or Courts of equivalent status
- (b) Legal practitioners with at least 15 years standing at the Bar at the level of the Supreme Court or the High Court; or the District Courts or Courts of equivalent status.
- (c) Experts or other professionals with at least 15 years standing; or retired senior bureaucrats or retired senior executives.

*(d) Institutions which are themselves experts in mediation and have been recognized as such by the High Court, provided the names of its members are approved by the High Court initially or whenever there is change in membership."*

Considering the above Rule, it would be proper to call willingness for 40 hrs. Mediation Training Programme for those Advocates who are eligible for empanelment as per Rule 4. Therefore, you are requested to call willingness of such Advocates and submit the figures from your District on or before 05.02.2024.
