All the candidates are hereby informed that, the Hon'ble Supreme Court, vide order dated 09/07/2024, has been pleased to dismiss the Petition(s) for Special Leave to Appeal (C) No. 11351/2024. In the light of the same Hon'ble Bombay High Court has been pleased to direct to resume the Central Online Recruitment Process-2023 and same has been resumed. All the candidates are requested to take a note as follows :

1. The candidates (whose submission and verification process has been completed during the period from 15/05/2024 to 21/05/2024 as per the instructions given in the notice dated 09.05.2024) are hereby informed to visit the concerned District Courts during the period from 16/07/2024 to 22/07/2024 alongwith the duly verified Admit Card already downloaded by them to rectify the earlier given exam dates (if given) and get the new exam dates on the Admit Card which is already verified and returned by concerned District Court.

Also the candidates who have downloaded and got the same verified from the concerned District Court, if the Admit Card may have been lost, misplaced or destroyed, shall download the fresh Admit Card from their respective login ID and produce the same before the concerned District Court for verification and shall follow the instructions given below at 2. (a to c).
