**ORDERS:**

1. The Hon'ble High Court, Madras in the Official Memorandum first read above, has directed the Principal District Judge, Tiruvallur District to constitute the Subordinate Courts Gender Sensitization and Internal Complaints Committee (GSICC) as per the Regulation 4 of the “ THE GENDER SENSITIZATION & SEXUAL HARASSMENT OF WOMEN AT THE SUBORDINATE COURTS IN THE STATE OF TAMIL NADU / THE UNION TERRITORY OF PUDUCHERRY (PREVENTION, PROHIBITION AND REDRESSAL) REGULATIONS, 2013”.

2. Accordingly, Gender Sensitization and Internal Complaints Committee (GSICC) was reconstituted on 08.07.2022 in the reference 2<sup>nd</sup> read above.

3. Tmt. M.Chithra Mala, Advocate, Member is relieved as per her request in the reference 3<sup>rd</sup> cited.

The term of the members of the GSICC nominated on 28.09.2021 is extended for another term of 2 years as per Regulation 5 of GSICC Regulations.

The nomination of Tmt. L.Vijayalakshmi, Advocate by the District Lawyer Association, Tiruvallur is accepted. The President, Advocate Clerks Association, Tiruvallur has submitted that there are no women members eligible for nomination.
