Subject: To make video conferencing facility functional for dealing with very urgent matters.

Reference: District Court Circular dated 26-03-2020.

In the wake of outbreak of Covid-19, the undersigned made available the facility of video conferencing for the advocates and litigants in person for hearing of all urgent matters by installing 'VIDYO' software on their computers or smart-phone, in addition to that in view of information received from central project co-ordinator, Bombay High Court the undersigned is making the following arrangement at head quarter and taluka Courts.

1. One V.C. unit is made functional in Room No. 5 at ground floor (adjacent to Server/computer room) for hearing urgent matters of Principal District and Sessions Judge and Ad-hoc District Judge and Additional Sessions Judge Nandurbar.
2. One V.C. unit is made functional in Room No. 5 at ground floor (adjacent to Server/computer room) for hearing urgent matters of including remand work Chief Judicial Magistrate and all Civil Judges (Unior Division) and J.M.F.Cs, in Dsittrict head quarter, Nandurbar.
3. One V.C. unit is made functional in Room No. 5 at ground floor (adjacent to Server/computer room) for hearing urgent matters of including remand work Chief Judicial Magistrate and all Civil Judges (Unior Division) and J.M.F.Cs, in Dsittrict head quarter, Nandurbar.
4. The District Judge-1, Shahada and all the Principal Magistrates at Taluka level are instructed to install one V.C. unit for urgent work of District Court and one V.C. Unit for remand and urgent work in JMFC and CJSD Court.

The arrangement is made functional with effect from 6th April 2020.

All the Principal Judges of the respective establishment at Taluka Courts are instructed to follow the intructions given above and take up the urgent hearing of the matters through Video conferencing.


