CIRCULAR

It is hereby brought to the notice of all the Members of the Supreme Court Employees' Mutual Welfare Fund (hereinafter referred to as "The Welfare Fund") that the Competent Authority vide order dated 13/08/2022 has been pleased to approve the amendments proposed in sub-clauses (a) & (b) of Clause 3 and sub-clauses (a), (c), (f) and (i) of Clause 8 of the Bye-Laws of the Supreme Court Employees' Mutual Welfare Fund, as per Resolution passed in the meeting of the Managing Committee of the Welfare Fund held on 21st July, 2022.

The existing sub-clauses (a) & (b) of Clause 3 and sub-clauses (a), (c), (f) and (i) of Clause 8 of the Bye-Laws of the Welfare Fund have been amended to read as under:-

A sum of Rs.10,000/- per month subject to the maximum payment of Rs.1,00,000/- covering the maximum period of such leave.
8(f)	Cash Award	A Cash Award of Rs. 11,000/- (rupees eleven thousand) each along with a Certificate issued by the Welfare Fund shall be given in the month of	A Cash Award of Rs. 21,000/- (rupees twenty one thousand) each along with a Certificate issued by the Welfare Fund shall be given in the month of July/August every

(Provided that no claim shall lie for financial assistance against the Fund as a matter of right and financial assistance in every case shall be afforded subject to the availability of sufficient amount in the Fund.)
