TERMS AND CONDITIONS

- 1. The bid will be confimed in favour of the person quoting lthe highest rate in respect of that vehicle. The auction will be held in the Supreme Court Complex.
- 2. Only those bidder shall be eligible for bidding, who deposit refundable amount of Rs.2,000/- (Rupees Two Thousand only) by way of demand draft/pay order drawn in favour of "SUPREME COURT LEGAL SERVICES COMMITTEE, NEW DELHI" as Earnest Money with the Supreme Court Legal Services Committee on or before 21.02.2019 upto 4.00 p.m. writing their name, name, telephone /mobile no. on the reserve side of the demand draft/pay order which will be refunded to the unsuccessful bidders on the spot. The person interested to bid should bring proof of his identity.
- 3. To be eligible for bidding, the bidder shall alongwith depositing the earnest, submit written bid in closed cover in proforma (Annexure 'A') for purchase of vehicle. The written bid shall not be less than the reserve price of the vehicle, as mentioned in clause 10 but may be more than that.
- 4. Before start of auction of such vehicle, closed cover bids received for the vehicle shall be opened and declared.
- 5. At the time of auction, no bidder shall be permitted to bid for

vehicle for an amount less than the reserve price of the particular vehicle as mentioned in clause 10 or the highest written bid received, whichever will be more.

- 6. 50% of the bid amount is to be deposited by the highest bidder immediatley on the spot whose bid will be provisionally accepted by way of cash/demand draft / pay order after adjusting the Earnest Money already deposited as referred in clause 2 above. If the amount is not deposited, the earnest money will be forfeited and that vehicle will be put in auction again and the bidder will be barred from participating in auction further.
- 7. On final acceptance of the bid, the remaining 50% amount is to be deposited by the highest bidder within one week of communication of the acceptance to him, failing which 50% amoung already deposited shall stand forfeited and vehicle will be sold in auction. On such deposit, the vehicle will be handed over to such person.
- 8. The SCLSC will deal with the bidder directly and no middlemen/agents/commission agents etc. should be asked by the bidders to represent their cause and they will not be entertained by the Registry. At the bidding, any bidder trying to form cartel with other bidders to otherwise influence the bidding process may be evicted and his/her earnest money may be liable to be conficated.
- 9. Conditional bid will not be entertained. If the bid is withdrawn by the concerned party at any time after it is provisionally accepted, the entire money already deposited by him/her shall stand forfeited.
- 10. The reserve price of the car is mentioned below:

- 11. The SCLSC, in its discretion, reserves the right to reject or accept any or all the bids, partly or completely, at any time without assigning any reason therefor. The decision of the Committee of Officers conducting the auction shall be final.
- 12. It shall be presumed that the bidder has fully inspected the car before the auction. The SCLSC shall not be responsible and shall not entertain any complaint in respect of any defect in the vehicle.

- 13. The Officers/staff of the SCLSC and their family members shall not be permitted to participate in the auction.
- 14. The successful bidder shall get the vehicle transferred in his/her name as per rules, at his own cost and responsibility, immediately on taking delivery and in any case within fortnight. SCLSC shall not in any manner be concerned with or responsible for registration of the vehicles, and will have no liability whatsoever after the delivery of vehicle to the successful bidder.
