

## **INFORMATION OF COMPLETE CASE DETAILS ON THE WEBSITE**

The Tab "Case Status" on the new website, serves as a comprehensive as well as integrated aperture for obtaining variety of information regarding cases (Pending/disposed).

Once a user clicks on the Tab "Case Status", he or she can obtain the case information by using various newly integrated methods which are as follows:

- By entering Diary No.
- By entering Case No.
- By entering Party Name
- By entering Advocate Name
- By entering High Court No. (New Feature)
- By entering Filing Defects (if any), and
- By entering Free Text (of the case).

Just as a **User** enters any of the aforesaid details and clicks on the "Submit" option the **Title** of the case along with a myriad of information appears on the screen which is segregated under the following heads:-

<b>Tagged Matters</b>	<ul style="list-style-type: none"><li>• Already filed matters in which the same Impugned Order has been challenged.</li></ul>

<b>Listing Dates</b>	<ul style="list-style-type: none"> <li>• All dates on which the case was listed for hearing along with next <b>tentative</b> hearing date.</li> <li>• Coram of Hon'ble Judges before whom the case was listed for hearing.</li> <li>• Remarks (if any).</li> </ul>
<b>Interlocutory Applications/ Documents</b>	<ul style="list-style-type: none"> <li>• Particulars (Nature) of the interlocutory application.</li> <li>• Name of the applicant along with Date of filing the application.</li> <li>• Status of the application-Disposed (D) or Pending (P).</li> </ul>
<b>Court Fees</b>  <b>Notices</b>	<ul style="list-style-type: none"> <li>• Total Amount of Court Fees and actual fees paid.</li> <li>• Notice(s) issued (if any) along with the option of tracking the stage/status of service of said notice(s).</li> </ul>

<b>Judgment/Orders</b>	<ul style="list-style-type: none"> <li>• Judgments/orders in cases which have been disposed.</li> </ul>
<b>Adjustments</b> <b>Mention Memo</b>	<ul style="list-style-type: none"> <li>• Adjournment letters/Circulation.</li> <li>• Memo for mentioning, if any.</li> </ul>
