Educational Qualification	:	Degree of a recognized University The candidate must have knowledge of computer operation
Experience	:	Minimum 7 years experience in maintenance and supervision of security of large buildings. OR Minimum 3 years service in the rank of Assistant Commissioner of Police or equivalent post in a police or Para Military Organization.
Age (as on 20.08.2024)	:	Below 56 years

General Information

- 1. The period of deputation is, initially, fixed as one year which may be extendable further. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization or department of the Central Government shall ordinarily not to exceed three years.
- 2. The pay of official appointed on deputation will be fixed as per the instructions issued by Government from time to time.
- 3. The applicants who are eligible and can be spared in the event of selection may forward their application through proper channel alongwith No Objection Certificate, Vigilance Clearance and attested copies of ACRs/APARs for the last five years to Recruitment Cell,

Supreme Court of India, Tilak Marg, New Delhi-110001 by **20.08.2024**. Applications received after due date shall not be entertained.

- 4. The applications not received through proper channel, without supporting documents, photograph, unsigned and incomplete in any manner will not be considered and will stand rejected.
- 5. The eligible candidates will have to appear for a computer test regarding their knowledge of computer operation and those who qualify the computer test will have to appear for an Interview before an Interview Board. No TA/DA will be paid to the candidates for appearing in the computer test or interview.
- 6. The candidates who qualify in both computer test and interview will be considered against appointment to the ex-cadre post of Additional Registrar (Security) in the order of merit and his/her appointment will not confer upon him/her any right or title to claim appointment on the ex-cadre post or promotion in the regular channel.
