- 2. Buddha Purnima falls on 17th May (Tuesday) during Summer Vacation and the Registry will also remain closed on this day. Mahatma Gandhi's Birthday falls on 2nd October (Sunday).
- 3. Holi, Dussehra and Diwali actually fall on Sunday, the 20th March, Thursday, the 6th October and Wednesday, the 26th October, 2011 respectively.
- 4. The Summer Vacation of the Court will commence on Monday, the 16th May, 2011 and the Court will resume its sitting on Monday, the 4th July, 2011. The Summer Vacation is shaded in red.
