- 3. Holi, Dussehra and Diwali actually fall on Friday, the 6th March, Thursday, the 22nd October and Wednesday, the 11th November, 2015 respectively,
- 4. The Summer Vacation of the Court will commence on Monday, the 18th May, 2015 and the Court will resume its sitting on Wednesday, the 1st July, 2015. The Summer Vacation is shaded in Orange. The Registry of the Court will, however, be functioning throughout the vacation except on Saturdays, Sundays and Holidays. - During the Christmas/New Year Holidays, the Registry will remain closed from 25th December, 2015 to 1st January, 2016 (Both days inclusive).
