IMPORTANT INSTRUCTIONS FOR THE CANDIDATES FOR PRACTICAL TRADE SKILL TEST

- Candidates are advised to visit the Test Centre for Practical Trade Skill Test in cooking at least one day in advance and familiarize themselves with its location to avoid the last minute hassle in their own interest. They should reach the Centre of the Practical Trade Skill Test well in time for Bio-metric attendance.
- Entry to the Test Centre is strictly permissible against the Admit Card alongwith one Original ID Proof, therefore, the candidates must bring atleast one document in Original as proof of their Identity like Aadhaar Card, Voter Card, Driving License, Pan Card, Passport etc. to be shown at the entry point of Test Centre on the date of Practical Trade Skill Test.
- 3. Please note that Practical Test is being arranged at Indian Navy facility in Delhi and candidates must report at the centre as per their reporting time. Late comers may be denied entry by Navy personnel.
- 4. Candidates in possession of Mobile Phone etc. will not be allowed to keep these with them at the time of test. The candidate shall have to keep the same in the rack available at the Navy centre. The Indian Navy or Registry of Supreme Court of India will not be responsible for any loss in this regard.
- 5. The candidates are advised not to wear any kind of jewellery, ring, bracelets etc. at the time of test and bringing of articles such as Books, Notes & Loose Sheets etc. in the Test Centre is strictly prohibited.
- 6. Your admission to the Practical Trade Skill Test in cooking is strictly provisional & subject to fulfilment of all the conditions of eligibility as all the candidates are being allowed provisionally without adjudging their eligibility as per advertisement at this stage. If, at a later stage you are not found eligible, your candidature will be cancelled without any notice.
- 7. Candidate should strictly follow the instructions given to them by the Navy personnel and/or officers of the Registry of Supreme Court of India at the test centre.
- 8. No candidate will be permitted to leave the Test Centre before completion of full time of the test.
- Physically disabled candidates will not be allowed any extra time in the practical trade skill test.

- 10. All ingredients required for/in the Practical Trade Skill Test in cooking will be provided at the Test Centre. The candidates need not bring even a single ingredient/cooking item to the Test Centre.
- 11. No person other than candidate will be allowed to gain entry inside Navy facility in Delhi.
- 12. The practical evaluation consists of preparation of food using cooking station. The candidates are advised to not wear synthetic clothes and loosely fitted clothes at the time of practical evaluation.
- 13. Any misbehaviour or misconduct during the test may lead to forfeiture of candidature.

INSTRUCTIONS FOR APPEARING IN THE INTERVIEW

- 14. The candidates are required to produce any document as proof of their Identity like Aadhaar Card, Voter Card, Driving License, Pan Card, Passport etc. on the date of interview.
- 15. The candidates are directed to also bring original certificates pertaining to their educational qualification, professional qualification like diploma in cooking/culinary arts or other equivalent/higher qualification and work experience and also caste certificate, PwBD certificate, Ex-servicemen certificate, wherever applicable along with one set of photocopy of these documents duly self-attested for verification.
- 16. The candidates are also required to produce character certificate at the time of interview duly attested by Gazetted officer and counter-signed by Executive Magistrate/SDM/Tehsildar/Naib-Tehsildar. The format of character certificate is appended below.
- 17. Candidates are required to carry this Admit card for both in Practical Trade Skill Test and Interview.
- 18. Candidates working in State/Central Govt. departments/Banks/ PSUs etc. will be required to submit No Objection Certificate at the time of interview.
