**NOTICE INVITING BIDS**

**Notice for disposal of condemned furniture scrap and other misc. items on**

Sealed bids are invited for disposal of condemned furniture scrap and other misc. items on “As Is Where Is Basis” and “Whatever There Is Basis.” The items shall be sold to the bidder who will quote the **consolidated highest rate**. The bids are invited for the whole lot (i.e., all the items contained in the list as detailed at Annexure ‘A’ and no bid shall be accepted for any part of the same.

**Instructions and Terms & Condition:-**

- 1) The bidder may inspect the said condemned items from 05.11.2024 to 11.11.2024 between 11:00 a.m. and 3:00 p.m. on any working day.
- 2) Two separate sealed envelopes should be used for submitting ‘Earnest Money Deposit’ and ‘Financial Bid’ respectively, subscribing on the envelopes (a) Earnest Money for disposal of Condemned Furniture Scrap and other misc. Items and (b) Financial bid for sale of condemned furniture scrap and other misc. items per Annexure ‘B’, addressed to the Assistant Registrar, Admn. Materials. The sealed envelopes shall be received latest by 12.11.2024 till 12:00 pm at Counter Nos. 25 & 26 (R&I), Supreme Court of India Main Building, Tilak Marg, New Delhi, which will be opened on the same day at 3:00 p.m. in presence of bidders or their authorised representatives, if they want to be present.
- 3) The representatives of the bidders who would like to participate in the bid process should inform in advance regarding their participation, so that their entry in the premises of the Supreme Court is regularised. They should also bring their valid identity card etc. for the purpose.

- 4) No bid either by post or by hand shall be received after the specific time and date mentioned above. No extension of date and time shall be allowed.
- 5) Earnest Money/Bid Security of Rs. 20,000/- (Rupees Twenty Thousand only) in the form of an Account Payee Demand Draft drawn in favour of "The Registrar, Supreme Court of India, New Delhi" will have to be deposited along with financial bid documents by due date at Counter Nos. 25 & 26 (R&I), Supreme Court of India Main Building, Tilak Marg, New Delhi. Name of the firm, telephone no. and name of the job are to be indicated on the reverse side of the Demand Draft.
- 6) The consolidated amount shall have to be deposited within 02 days from the date of communication regarding acceptance of bid, failing which EMD deposited shall be liable to be forfeited.
- 7) The condemned items will be delivered/ handed over to the highest bidder within the office premises, only after deposit of full payment.
- 8) The condemned items will have to be lifted within 05 working days after depositing the bidding amount. All costs including transport and labour shall have to be borne by the highest bidder.
- 9) Once the release order is issued, the Supreme Court Registry will not be responsible either for safe custody or for any loss or damage to the condemned items.
- 10) The Supreme Court Registry reserves the right to reject any or all the bids without assigning any reason. It also reserves the right to withdraw the said condemned items for the disposal without assigning any reason thereof. The decision of the Supreme Court Registry shall be final in this regard during the process of Bidding at any stage.
