If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. The Registry will deal with the Bidder directly and no middle-men/ agents/ commission agents etc. should be asked by the bidder to represent their cause and they shall not be entertained by the Registry. The bid form is not transferable and the agency shall not be permitted to transfer their rights and obligations to any other person/ organization or otherwise.
6. The Registry, in its discretion, reserves the right to make any change, at any time, in the terms and conditions of the custom bid and reject or accept any or all the bids, wholly or partly, without assigning any reason thereof.
7. The Bidder shall give an undertaking (as per Annexure A) that the Firm/Partners/Director/Proprietor has not been blacklisted and its business dealings with Central/ State Government/ Public Sector units/ Autonomous bodies have not been banned/terminated on the account of poor performance.
8. The Performance Security deposit shall stand forfeited in case of breach of any of the conditions mentioned herein and if the supply is found unsatisfactory.

#### **B. PAYMENT TERMS AND CONDITIONS FOR SUCCESSFUL BIDDER**

1. The bidder should specifically state whether rates are inclusive of GST (as applicable) and if the same are not stated, it will be deemed that the rates are inclusive of GST.
2. The successful bidder shall have to give performance security deposit @ 3% of total amount of the Purchase Order by way of Bank Guarantee / Demand Draft drawn in favour of “The Registrar (Admn.)
