Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Supreme Court of India, an apex Judicial Body under Constitution of India intends to invite online bids/ tenders through GeM portal from Delhi/NCR based reputed firms/manufacturers/authorised dealers/distributors, as per the Proforma attached herewith at Annexure 'A', for supply of 03 (three) nos. of TVS iQube Electric Scooters (base model as per GeM) along with helmets (ISI mark).

Manual bids shall not be accepted under any circumstances. The offer submitted by fax / email shall not be considered. No correspondence will be entertained in this matter. The tenderers are, therefore, required to quote rates online on GeM Portal only.

2. **DOCUMENTS DOWNLOAD**

2.1 The bids/ tenders are to be submitted online on GeM Portal in strict compliance to the schedule mentioned in the Critical Date Sheet given hereunder:

- 2.2 Tender documents are also available on Supreme Court of India website https://www.sci.gov.in/notice-category/tenders/ (for reference only).
- 2.3 Not more than one tender shall be submitted by one Bidder or Bidders having business relationship. Under no circumstance will father and his son(s) or other close relations who have

business relationship with one another (i.e., when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable to rejection.

- 2.4 The tenderer shall not tamper/modify the tender form including downloaded price bid template in any manner. In case the same is found to be tampered/modified in any manner, tender will be summarily rejected and tenderer will also be liable to be banned from doing business with the Registry for a specified period as deemed fit.
- 2.5 The tenderers are advised to regularly visit GeM Portal and official website of Supreme Court of India i.e. https://www.sci.gov.in/notice-category/tenders till the closing date of submission to keep themselves updated with any change/ modification in the tender which will be intimated through this website only by corrigendum / addendum/ amendment. **No individual correspondence shall be entertained in this regard.**
- 2.6 The tenderers are required to quote their competitive rates for the said two-wheelers on GeM portal as per the GeM guidelines.

(A) ELIGIBILITY CRITERIA

- 3. The eligibility criteria for the Prospective Tenderer which need to be complied with the technical bid and will form part of Technical Evaluation is as follows:
 - a) The bidder should be the authorized seller of TVS, and, therefore, should submit Original Manufacturer's Authorization Letter (as per proforma at Annexure 'C') for supply of 03 (three) nos. of TVS iQube Electric Scooters (base model as per GeM).
 - b) Bidder must have valid GST Registration Certificate. A copy of the same should be enclosed with the Bid.
 - c) Bidder must have PAN (Permanent Account Number) and a copy of the same should be enclosed with the Bid.
 - d) The Bidder must have an office in Delhi/NCR, to support the after sale services and a copy of address proof must be submitted .
 - e) The bidders/ tenderers shall give an undertaking (as per Annexure -'B') that the Firm/Partners/Director/Proprietor has not been blacklisted and their business dealings with Central/State Government/Public Sector Units/Autonomous Bodies have not been banned/terminated on the account of poor performance.

(B) GENERAL TERMS AND CONDITIONS

- 4. The bidders/tenderer must read all the instructions, Proforma's terms & conditions and specifications carefully and ensure compliance with the instructions herein. Failing to furnish all the information as required by the tender document in any respect will be at the bidders'/tenderers' risk and may result in rejection of the bid/tender.
- 5. Certified translated copy of supporting documents should be uploaded in English, in case of

documents available in Regional/vernacular language.

- 6. The Registry will deal with the tenderer directly and no middle-men/agents/commission agents etc., should be asked by the tenderer to represent their cause and they will not be entertained by the Registry.
- 7. Rates quoted in the tender will be final and under no circumstances rate revision will be allowed.
- 8. The Tenderers are required to quote their rates **excluding Insurance and Road Tax** for the above mentioned **03 (THREE) NOS. OF TVS IQUBE ELECTRIC SCOOTERS (BASE MODEL AS PER GEM) ALONG WITH HELMETS (ISI MARK)**.
- 9. The rates should be valid for a minimum period of 90 days from the date of opening of tenders. The tenderer shall not be entitled during the said period of 90 days to revoke or cancel its tender or to vary the tender or any terms thereof.
- 10. Hypothetical or conditional Tenders will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered. In the event of the tender being withdrawn/altered, the tenderer may be debarred to participate in the tender process of the Registry.
- 11. The Registry will deal with the tenderer directly and no middlemen/ agents/commission agents etc. should be asked by the tenderer to represent the cause and they will not be entertained by the Registry. The Tender Form is non transferable and agency shall not be permitted to transfer its rights and obligations to any other person/organization or otherwise.
- 12. The Registry reserves the right to seek clarification or verification of any information supplied by the vendor.
- 13. Over-writing/over-typing or erasing of the figures, not countersigned by the Authorised Signatory, which render it doubtful or ambiguous, shall render the tender invalid.
- 14. The Registry, in its discretion, reserves the right to make any change, at any time, in the terms and conditions of the Notice Inviting Tender and accept or reject any or all the tenders, wholly or completely, without assigning any reason thereof at any stage of tendering process.
- 15. Rates quoted should be inclusive of **F.O.R/Freight/Temporary Registration/Delivery/ Number Plate fitting charges** at Supreme Court of India Registry.
- 16. The Registry is not bound to accept the rates submitted by the lowest tenderer or any other tenderer nor does it undertake to assign any reasons for its decision in this matter.
- 17. The Registry shall have the discretion to withdraw the contract at any time without any notice and without assigning any reason thereof.

- 18. The supply of **03** (**THREE**) **NOS. OF TVS IQUBE ELECTRIC SCOOTERS** (**BASE MODEL AS PER GEM**) **ALONG WITH HELMETS** (**ISI MARK**) will be inspected by an Inspection Committee of Senior Officers of the Registry at the time of delivery and in case the vehicle(s) is/are not found in conformity with the approved specifications, the vehicle(s) will have to be replaced exactly commensurate with approved specifications at the cost of the tenderer. The decision of the Committee in this regard shall be final.
- 19. The payment shall be made to bidder/Authorised Dealer electronically for which the bidder shall provide necessary details of the bank account etc. Applicable Taxes shall be deducted at source in accordance with the provisions of Government of India.
- 20. The successful bidder shall be responsible to get the HSRP (number plate), complementary accessories (if any), etc. affixed on the vehicles, at the time of delivery of the vehicles and at the Supreme Court premises at its own cost.
- 21. The successful bidder will have to abide by the terms and conditions as may be fixed from time to time by the Registrar, Supreme Court of India, New Delhi.

22. **PART –II: Price Bid contain following:**

- (i) The Price Bid shall contain only schedule of rates duly filled in. NO stipulation, deviation, terms & conditions, presumptions etc. is permissible in price part of the bid. The Registry shall not take any cognizance of any such conditions and may at its discretion reject such price bid.
- (ii) Bidders shall submit the tender online on GeM Portal on or before the due date and time of bid submission. Tender submitted by any other form (fax/email/courier/post/hard copy) will be summarily rejected.

(C) PAYMENT TERMS

- 23. The payment will be made only after the satisfactory delivery of the vehicles and its acceptance as per approved specifications. No part payment or Advance Payment will be made to the successful bidder.
- 24. Penalty. If any, shall be deducted from any of the outstanding payment due to the tenderer.
- 25. Statutory deductions shall be made as per applicable taxes.

(D) PENALTIES/ LIQUIDATED DAMAGES

- 26. Since the time is essence of the tender, delivery of the vehicles shall be required to be made **within 15 days** on receipt of the Purchase Order and in case vehicles are not received within the stipulated time and the Registry is forced to make purchase from outside to meet the urgent demand, the loss, if any, would be recovered from the tenderer.
- 27. Irrespective of the fact as to whether or not the Registry makes purchase from outside, the Registry may impose penalty of 1% per month subject to maximum of 10% of the total cost, for

delayed delivery, if the delay is due to willful laches or negligence of the tenderer and it causes financial loss or inconvenience to the Registry.

- 28. In the event that any employee of the Service Provider is found liable for theft, loss, or damage to office property, the Service Provider shall be held accountable for any resulting compensation claims.
- 29. Any loss/damage sustained to the Registry will be recovered from the successful tenderer.

(E) TRANSFER/SUB-LETTING

30. The firm/bidder has no right to give, bargain, sell, assign or sublet or otherwise dispose of the contract or any part thereof, as well as to give or to let a third party take benefit or advance of the present Contract or any part thereof.

(F) INTELLECTUAL PROPERTY RIGHTS

31. Supreme Court of India Registry shall be solely entitled to any Intellectual Property Right (IPR) emanating or in any way related to this tender bid/ process. If any infringement to such IPR is observed during the currency of the contract or any time thereafter, suitable legal action may be initiated by the Supreme Court of India Registry.

(G) CONFIDENTIALITY OF CONTRACT

32. The successful bidder/ tenderer shall ensure that the specific terms and conditions of the contract will also be treated as confidential information and that no disclosures will be made in any form without the prior written consent of the Supreme Court of India Registry, except (i) As required by applicable disclosure law; (ii) To accountants, Banks, Financing Sources, lawyers, etc., subject to a duty not to disclose to others or (iii) in connection with the enforcement of this contract.

(H) JURISDICTION

32. Since the contract shall be governed by and interpreted under, the laws of the Republic of India and Courts at Delhi shall have exclusive jurisdiction to try, entertain and decide the matters arising out of and in relation to the Contract. All disputes and differences are, however, subject to the jurisdiction of the courts situated in Delhi.

(I) ARBITRATION

- 33. In the event of any dispute or difference or disagreement between the parties in respect of any matter relating to or arising out of the Agreement/ Contract, the parties shall endeavor to resolve amicably any such disagreement or dispute by direct informal negotiation.
- 34. If the parties fail to resolve such a dispute or difference or disagreement by mutual consultation within twenty eight (28) days from the commencement of such consultation, either party may require that the dispute be referred for resolution to the Competent Authority.

(J) FORCE MAJEURE

35. In case the successful bidder/ tenderer is unable to fulfill the obligation under the contract owing to Force Majeure situation like war, fire, earthquake, floods, embargoes, act of terrorism etc., which are beyond the control of the parties, the successful bidder/ tenderer shall promptly notify Supreme Court Registry in writing of such condition and cause thereof. Unless otherwise directed by Supreme Court of India Registry in writing, the successful bidder/ tenderer shall continue to perform its obligations under the contract as far as it is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
