LIMITED NOTICE INVITING TENDER
(FROM ORIGINAL EQUIPMENT MANUFACTURER (OEM) AND THEIR DELHI/NCR
AUTHORIZED DEALERS)

(i) FOR SUPPLY OF 34 (THIRTY FOUR) NOS. OF TVS IQUBE (2.2 kWh) ELECTRIC SCOOTERS (GREY COLOR) ALONG WITH HELMETS (ISI MARK)

OR

(ii) FOR SUPPLY OF 34 (THIRTY FOUR) NOS. OF BAJAJ CHETAK 3503 ELECTRIC SCOOTERS (GREY COLOR) ALONG WITH HELMETS (ISI MARK)

1. Supreme Court of India, an apex Judicial Body under Constitution of India intends to invite Sealed tenders for supply of *either*

(i) “34 (thirty four) nos. of TVS iQube (2.2 kWh) Electric Scooters (Grey Color) along with helmets (ISI mark)”

or

(ii) “34 (thirty four) nos. of Bajaj Chetak 3503 Electric Scooters (Grey Color) along with helmets (ISI mark)”

from Original Equipment Manufacturers and their Delhi/NCR based authorised dealers/distributors, as per the Proforma attached herewith at Annexure 'A'.

2. **A single sealed** envelope should be used for submitting Tender document **superscribing** on the envelope “Tender for supply of 34 (thirty four) nos. of TVS iQube (2.2 kWh) Electric Scooters (Grey Color) along with helmets (ISI mark)” *or* “Tender for supply of 34 (thirty four) nos. of Bajaj Chetak 3503 Electric Scooters (Grey Color) along with helmets (ISI mark) ”.

3. **No EMD and Performance Security are required to be submitted by the bidder.**

4. The duly sealed tender may be sent by post/ in person or may be delivered at **e-SEWA Kendra Counter number 25 and 26 (R&I), Main Building, Supreme Court of India, Tilak Marg, New Delhi-110001**, sufficiently early so as to reach the Registry latest by **17th March, 2026 (04:00 p.m.)**. If tender is sent through Messenger, an authority letter from the tenderer with proof of identity may also be given to the Messenger so that he/she can show the same along with his/her own identity proof at **e-SEWA Kendra Counter number 25 and 26 (R&I), Main Building,**

Supreme Court of India, Tilak Marg, New Delhi-110001 .Tender documents are also available on Supreme Court of India website <https://www.sci.gov.in/notice-category/tenders>.

(A) ELIGIBILITY CRITERIA

5. The eligibility criteria for the Prospective Tenderer which need to be complied with the technical bid and will form part of Technical Evaluation is as follows:

- a Bidder/tenderer should be the authorized seller/dealer of *either* TVS *or* Bajaj, and, therefore, should submit Original Manufacturer's Authorization Letter (as per proforma at Annexure 'C') for supply of the requisite brand/make of scooter.
- b Bidder/tenderer must have valid GST Registration Certificate. A copy of the same should be enclosed with the Bid.
- c Bidder/tenderer must have PAN (Permanent Account Number) and a copy of the same should be enclosed with the Bid.
- d Bidder/tenderer must have an office in Delhi/NCR, to support the after sale services and a copy of address proof must be submitted .
- e Bidder/tenderer shall give an undertaking (as per Annexure -'B') that the Firm/Partners/Director/Proprietor has not been blacklisted and their business dealings with Central/State Government/Public Sector Units/Autonomous Bodies have not been banned/terminated on the account of poor performance.

Note: The bids not duly sealed, shall not be considered under any circumstances and shall be rejected summarily.

(B) GENERAL TERMS AND CONDITIONS

6. The bidders/tenderer must read all the instructions, terms & conditions and specifications carefully and ensure compliance with all the instructions herein. Failing to furnish all the information as required by the tender document in any respect will be at the bidders'/tenderers' risk and may result in rejection of the bid/tender.
7. Certified translated copy of supporting documents should be uploaded in English, in case of documents available in Regional/ vernacular language.
8. The Registry will deal with the tenderers directly and no middle-men/agents/commission agents etc., should be asked by the tenderers to represent their cause and they will not be entertained by the Registry.
9. Rates quoted in the bid/tender will be final and under no circumstances rate revision will be allowed.
10. The Tenderers are required to quote their rates excluding Insurance and Road Tax for the above mentioned brand/make of scooter.
11. The tenders will be evaluated based on meeting the eligibility criteria and on accepting terms and conditions etc. and shall normally be awarded to the lowest evaluated quotationer whose

bid has been found to be responsive and is eligible and qualified to supply the requisite material satisfactorily.

12. The **rates should be valid for a minimum period of 90 days from the date of opening of tenders**. The tenderer shall not be entitled during the said period of 90 days to revoke or cancel its tender or to vary the tender or any terms thereof.
13. Hypothetical or conditional Tenders will not be entertained. Tender once submitted shall not be allowed to be withdrawn or altered. In the event of the tender being withdrawn/altered, the tenderer may be debarred to participate in the tender process of the Registry.
14. The Registry reserves the right to seek clarification or verification of any information supplied by the vendor.
15. Over-writing/over-typing or erasing of the figures, not countersigned by the Authorised Signatory, which render it doubtful or ambiguous, shall render the tender invalid.
16. The Registry, in its discretion, reserves the right to make any change, at any time, in the terms and conditions of the Notice Inviting Tender and accept or reject any or all the tenders, wholly or completely, without assigning any reason thereof at any stage of tendering process.
17. Rates quoted should be inclusive of **F.O.R/Freight/Temporary Registration/Delivery/ Number Plate fitting charges** at Supreme Court of India Registry.
18. The Registry is not bound to accept the rates submitted by the lowest tenderer or any other tenderer nor does it undertake to assign any reasons for its decision in this matter.
19. The Registry shall have the discretion to withdraw the tender at any time without any notice and without assigning any reason thereof.
20. The supply of the requisite brand/make of scooter will be inspected by an Inspection Committee of Senior Officers of the Registry at the time of delivery and in case the vehicle(s) is/are not found in conformity with the approved specifications, the vehicle(s) will have to be replaced with vehicle exactly commensurate with approved specifications at the cost of the tenderer. The decision of the Committee in this regard shall be final.
21. The successful bidder shall be responsible to get the HSRP (number plate), complementary accessories (if any), etc. affixed on the vehicles, at the time of delivery of the vehicles at the Supreme Court premises at its own cost.
22. The successful bidder will have to abide by the terms and conditions as may be fixed from time to time by the Registrar, Supreme Court of India, New Delhi.
23. Since time is the essence of the tender, the supply of the items as per the required specifications shall be required to be made within 15 days in the Registry (F.O.R. Destination) from the date of Supply Order.
24. In the event that any employee of the supplier is found liable for theft, loss, or damage to office property, the supplier shall be held accountable for any resulting compensation claims.

25. Any loss/damage sustained to the Registry will be recovered from the successful tenderer.

(C) PAYMENT TERMS

26. All payments to the bidder or authorized dealer will be processed electronically only. To facilitate this, the successful bidder must provide bank account details and cancelled cheque. The payment will be subject to all statutory tax deductions (TDS) as per Government of India provisions.

27. Payment shall be made upon the satisfactory delivery of vehicles and their formal acceptance based on the approved specifications. No advance or interim part-payments will be entertained under any circumstances.

28. Penalty, if any, shall be deducted from any outstanding payment due to the tenderer.

(D) FORCE MAJEURE

29. In case the successful bidder/ tenderer is unable to fulfill the obligation under the contract owing to Force Majeure situation like war, fire, earthquake, floods, embargoes, act of terrorism etc., which are beyond the control of the parties, the successful bidder/ tenderer shall promptly notify Supreme Court Registry in writing of such condition and cause thereof. Unless otherwise directed by Supreme Court of India Registry in writing, the successful bidder/ tenderer shall continue to perform its obligations under the contract as far as it is reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.

Name of the Officer – Shri Sanjeev Kumar Sinha, Branch Officer (AM), and only two (02) representative(s) will be allowed for each firm.
