

## RE - TENDER NOTICE

All concerned to note that this Office intends to sale Old Papers and Destructed Waste Papers and cardboards pertaining to the Head Office of this Court at Dhobi Talao, L.T. Marg, Mumbai- 400 002 and Branch office at Bhaskar Building, Anant Kanekar Marg, Bandra (East), Mumbai 400 051 to the Intending Purchasers/ Vendors.

In view of above, the Sealed Tenders / Quotations are invited from Intending Purchasers for sale of Old Papers, Destructed Waste Papers and Cardboard's of this Court through Tender Notice dated 27.01. 2025.

Accordingly, Intending Purchasers i-e Shreenath Paper Marts, Ashtavinayak Old Paper Marts and Ashok Shinde have submitted tender / quotations in the sealed envelopes to this office. The Purchase Committee comprising of Hon'ble Two Judicial Officers have opened the sealed quotations of above said Intending Purchasers. Shri. Ashok Shinde has quoted higher price compare to other two Intending Purchasers i-e Rs. 21.50 ps. Per Kg. But, the Amount quoted by Shri Ashok Shinde is lower in comparison to amount quoted by him in the year 2023-2024 i-e Rs. 26.50 ps. Per kg. The Hon'ble Purchase Committee has unanimously decided that the tender price should be more in comparison with the previous year i-e more than Rs. 26.50 ps per Kg. Accordingly, Hon'ble Purchase Committee decided to re-tender the process.

The Intending Purchasers shall submit Tender / Quotation in the sealed envelope addressed to the "**The Registrar, Court of Small Causes, L.T. Marg, Dhobi Talao, Mumbai – 400002**" and should reach in this Office on or before Thursday , the 13<sup>th</sup> March 2025 up

to 5.00 p.m On the top of the envelope, the words "Tender/Quotation for Purchase of Old Papers and Destructed Waste Papers" should be written. The Intending Purchasers shall mention full address and telephone/mobile number, at the bottom of the envelop, in order to enable this office to communicate the date of opening of the Tenders/ Quotations and to make further correspondence if any.

The Tenders/ Quotations to be received will be opened in the presence of the representatives of the Intending Purchasers / Tender Holders on the date to be fixed by the Office. The date of Opening of the Tenders/ Quotations will be communicated to the concerned. Accordingly, the necessary contract will be made for the period of One Year with the Purchaser/ vendor with a condition to deposit Rs. 9500/- with the Office as Security Deposit, which will be refunded after contract period is over.

The Tenders / Quotations received after due dates will not be considered.
