The intending bidders shall submit their sealed quotations in a sealed cover with reputed brands/make and relevant warranty etc.,


The award of the work order shall subject to following terms and conditions.

3. The successful agency should submit the advance stamped bill after the installation of the Air Conditioners with necessary work completion report endorsed by the concerned court Superintendent or any other staff member and shall submit the installation report to the undersigned.
4. All the products shall be of the year 2025 and the noise range shall be below 39dB and not to exceed 50dB in high mode.
5. Quantity of AC's may increase/decrease depending on the requirement at the time of finalization.
