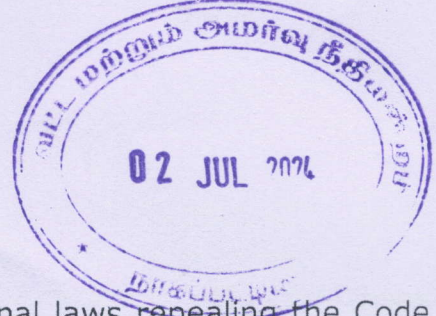

**ORDER:**

As per Police Standing Order 551(7), the First Information Report shall have the State emblem at the top of the page and the captions 1) "First Information Report" and 2) "Under section 154 Cr.P.C." shall be printed below the State Emblem both in English and Tamil juxtaposed.

2. Due to the coming into force of three new criminal laws repealing the Code of Criminal Procedure, 1973 (Central Act 2 of 1974), the Indian Penal Code (Central Act 45 of 1860) and the Indian Evidence Act, 1872 (Central Act 1 of 1872) with effect from 01.07.2024, the Director General of Police/Head of Police Force, Chennai in his letter read above, has requested to accord approval to change the title of already printed Type 1 & Type 2 FIR manually by way of rubber stamping with Station Housing Officer signature nearby. Considering the circumstances stated by the Director General of Police / Head of Police Force in his letter read above, the Government have carefully examined the said proposal of the Director General of Police / Head of Police Force, Chennai and decided to accept it.

Accordingly, the Government, under section 24 of the General Clauses Act, 1897 (Central Act, 10 of 1897), accord approval for the manually amended FIR, changing the title of printed Type 1 & Type 2 FIR by way of rubber stamping with the Station House Officer signature nearby so as to include section 173 of BNSS, 2023 replacing section 154 of Cr.P.C., till the new FIR Forms are printed and distributed.
